Purpose

- 1. The purpose of the instrument is to increase local and community bus services registration fees in line with corresponding increases being made by the Department for Transport in England and Wales. These are part of a wider package of increases to raise fee income for DFT's Vehicle and Operator Services Agency in line with operating costs.
- 2. These Regulations increase the fees for the registration of, or the variation of the registration of, a community bus service, other than a service supplied under an agreement providing for service subsidies, from £12 to £13 (an increase of 8.3%). The fees were last increased on 1st April 2007.
- 3. These Regulations also increase the fees for the registration of, or the variation of the registration of, a local bus service, other than a community bus service. The fee is increased from £57 to £60 (an increase of 5.3%). The fees were last increased on 15th September 2008.
- 4. Further information on the consultation can be found in the **Executive** note which is attached.
